LACA SUMMER 2007 JURIED SHOW AND COMPETITION AT PIERCE LAW CENTER, CONCORD, NH

In support of their mission to support the arts, culture and heritage of Newmarket and its surrounding communities, the Lamprey Arts & Culture Alliance (LACA) is pleased to announce their second annual juried art show and competition, "Exhibit A: Summer Art at Pierce Law," to be exhibited throughout the summer months at the prestigious Pierce Law Center, in Concord, NH.

As an addition to our seasonal group art showcases, and our individual artist-of-the-month exhibits, we wanted to provide local artists with another type of venue for displaying their creative talents. Pierce Law holds a number of summer programs at the school, with a great many visitors, and has once again invited LACA to display artwork at their beautiful facility for the months of June, July and August. In addition, we will be holding an awards ceremony/artist reception at Pierce Law, in conjunction with the Concord Chamber of Commerce's ArtConcord event in August.

EVENT: Exhibit A: Summer Art at Pierce Law, 2007 (LACA Juried Show and Competition)

LOCATIONS:

- Art drop-off, pick up, and jurying will take place at Ampers & Studio | Gallery in Newmarket, NH.
- The show and awards ceremony/artist reception will be held at Pierce Law Center, Concord, NH.

ELIGIBILITY: This show and competition is open to all artists in NH, ME and MA.

ACCEPTED MEDIA:

- Accepting all original 2-D works (including collages, hand-pulled prints, mixed media), up to 36" max in size.
- All entries **MUST** be framed and wired, and ready to hang (finished-edge canvases okay).
- Additionally, entries **MUST** be wrapped suitably for transport—preferably in bubblewrap—as artwork will be stacked and transported between Newmarket and Concord.
- Two (2) entries allowed per artist.

REGISTRATION INFO:

Deadline for registration is May 25. A non-refundable entry fee of \$10 per artist (free to current LACA members) is required. The entry fee also entitles entrants to a complimentary membership in LACA through 1-31-08. (See registration form, attached.)

IMPORTANT DATES:

- Art drop-off and jurying will take place at Ampers & Studio | Gallery in Newmarket, NH. Art Drop-off time is from 9-12 noon on Saturday, June 2.
- Judging will take place at 2 PM on Saturday. Jurors will select art to be included, and will also vote for their favorite three pieces for the "jurors' choice" award. Any piece with two juror votes shall be included in the show.
- LACA will notify artists of their accepted work(s) on Monday evening, June 4. Artists may pick up any non-selected pieces on Wed & Thu, June 6 & 7, from 10 to 1 and 3 to 6 PM each day.
- Art will be transported to Pierce Law Center and hung on Tuesday, June 5.
- The show opens on Wednesday, June 6. The school is open to visitors M-F, from 8 to 5 PM. Visitors to the school will be encouraged to vote for their favorite piece. Voting will take place up until an hour before the awards are given out at the reception. The top three vote getters will be awarded "viewer's choice" ribbons.
- On Friday, August 10, LACA will hold an artists' reception and awards ceremony at the Law Center, from 5-8 PM. All attending artists will be asked to bring a finger food for the reception. Beverages will be provided by LACA. We encourage all artists to be present for the event, to meet & greet the public and help to generate interest and support for the arts. Jurors' and Viewers' Choice winners will be announced at the reception.

- The show ends on Friday, Sept 7, after Pierce Law's Student Orientation.
- Unsold art will be taken down on Saturday, Sept 8 and returned to Newmarket. Artists may pick up their artwork at Ampers& Studio | Gallery on Mon, Tue or Wed, Sept 10-12, from 10 to 1 and 3 to 6 PM.

TERMS:

Every artist must complete, sign and submit the Registration/Agreement form below, along with registration fee of \$10, in agreement to the following terms:

- All pieces must be offered for sale, and prices will be set by the artist.
- All art sales will be handled by Pierce Law Center, and purchased art may be taken down at time of purchase. Artists selling works will be given first right of refusal to provide Pierce Law with a replacement work of art.
- ALL SALES WILL BE FINAL.
- LACA shall receive a 20% commission on all pieces sold; the artist will receive 80% of sales price. Payment shall be made to the artist by October 15.
- LACA shall not be held responsible for theft of or damage to any piece of artwork submitted in this competition.
